Based upon (decree No. 487 of 4th September 2014) - license given to establish the Academic University College for Non-violence and Human Rights (AUNOHR),

Based upon the Higher Education Council recommendation in session No. 2/2015 on 12th August 2015, resolution No. 15 assigned to the report of Technical Committee on 5th August 2015,

#### Decides on the following:

Article 1: the Academic University College for Non-violence and Human Rights (AUNOHR) is authorized to start teaching as of the academic year 2015/2016 in the following disciplines in Master level -2 years -30 credits:

- Non-violent education philosophy and skills
- Social training and active methods
- Conflict management and non-violent mediation
- Non-violent educational theater
- Civic and citizenship education
- Humans rights education culture and skills
- Non-violence philosophy and strategies
- Non-violent communication and media skills

- Culture of non-violence and human rights

# License to establish the Academic University College for Non-violence and Human Rights (AUNOHR).

The Council of Ministers,

Based upon the Constitution, especially Article 62 thereof,

Based upon Law No. 285 of 30<sup>th</sup> April 2014 (General Provisions for Higher Education and Regulation of Private Higher Education),

Based upon Decree No. 16676 of 18<sup>th</sup> June 1964 (identification of rules of procedure of the Higher Education Council),

Based upon Decree No. 9274 of 5<sup>th</sup> October 1996 and its amendments (specifying the conditions, specifications and standards required for licensing a private institution for Higher Education, or developing a college or institute in an existing institution),

Based upon the recommendation of the Higher Education Council during its 5/2014 session on 23/5/2014,

Based upon the proposal of the Minister of Education and Higher Education and after the approval of the Council of Ministers on 19<sup>th</sup> August 2014,

#### Decides on the following:

**Article 1:** The Lebanese Association for Civil Rights is authorized to establish the Academic University College for Non-violence and Human Rights and its campus in the city of Ayroun - Mount Lebanon, with the listed majors in the Master level:

- Non-violent education philosophy and skills
- Social training and active methods
- Conflict management and non-violent mediation
- Non-violent educational theater
- Civic and citizenship education
- Humans rights education culture and skills
- Non-violence philosophy and strategies
- Non-violent communication and media skills
- Culture of non-violence and human rights

**Article 2:** The institution shall be prohibited from starting teaching before the implementation of its commitments to provide the councils, buildings and teaching staff, and to provide academic, physical and financial supplies in accordance with the provisions of Law No. 285 of 30<sup>th</sup> April 2014.

Article 3: This decree shall be published and communicated when needed.
